Petition for Appointment of Guardian(s) of Minor(s) & Frequently Asked Questions



This packet contains information, instructions, and the petition for you to complete and file with the Court.

What is a Petition for Appointment of Guardian(s) of Minor(s)?

It is a written, legal request for guardianship of a minor.

What does "Petitioner" mean?

The Petitioner is the person or persons asking the Court to be appointed the guardian of a minor.

What is a Guardianship of a Minor Proceeding?

A guardianship of a minor proceeding is the Court process used to legally establish a guardian for a minor and to establish legal decision-making.

Should I see a lawyer for help?



Court cases can be very complicated, and even if you are representing yourself you may want to see a lawyer for legal advice as to how the law applies to you and what is best in your particular situation. This might save you time, money, and trips

to Court and help you to avoid serious mistakes. There are lawyers who will help you on a limited basis. They will only charge for giving the help you need, and you can complete the Court papers on your own or ask the lawyer for help.

In the Matter of the Guardianship of – Enter the name as the Minor(s).

Enter your name into black space. Please include names of all people assuming guardianship.

Series of True Statements to the Court:

- 1. Write the minor's complete date of birth. Please include all minors involved.
- 2. This line needs to include deceased or living names of parents of the minor. Also include their addresses, if known. If deceased, include dates of death.
- 3. The minor needs to either reside or be present in Pima County. If the minor is not in Pima County, you need to file in the county they are in.
- 4. No other guardianship proceedings have begun.
- Parental powers and responsibilities have been suspended by circumstances or terminated by Court order.

- 6. Explain, in detail, why a guardianship is necessary and in the best interests of the minor.
- 7. Enter your full name here. If there is another adult asking for guardianship with you for the same minor, enter their full name. Keep in order, your full name with your full date of birth. Then their full name with their full date of birth.
- 8. State your relationship with minor. Example: Grandparent, Aunt, Uncle, or friend.
- 9. List anyone who must to be notified. This includes the following:
 - o Parents
 - o Minor, if they are 14 years old or older.
 - Anyone who the minor has lived with in the last 60 days.

You must request that the Court appoint you as guardian of the minor. In the blanks requesting the Court to appoint a guardian, enter your full name here. If there is another adult asking for guardianship with you for the same minor, enter their full name too.
