### What Conciliation is for?



Conciliation is to assist married couples to make an informed and thoughtful decision regarding their marriage.

Sometimes one spouse will file for a divorce and the other spouse would like an opportunity to discuss what has happened in the relationship and whether or not a divorce has to occur.

Once one party files a conciliation petition, both parties are court ordered to attend a conciliation session. If there is a divorce case, it will be put on hold until the conciliation case is dismissed. If there are safety concerns, both parties might not be in the same room at the same time, but information can be relayed back and forth between the parties.

Conciliation is a free service through the Conciliation Court. You can use this packet to ask for this service. If you have any questions you may call (520) 724-5590.

If after you ask for the service you change your mind, you can file a withdrawal of the petition for conciliation. Only the person who filed the original petition for conciliation can complete and file the withdrawal form.

### What Conciliation is not for?



Conciliation is not mediation. If you are wanting help in coming up with a legal decision-making and/or parenting time plan for your children, you will want to look at Packet #15 which describes mediation and what you need to do to request that service.

Conciliation is not to force someone to make a decision, but an opportunity for spouses to communicate with the help of a third party.

If you need help in filing for a divorce, go to www.sc.pima.gov to find the proper forms.

# **Instructions for Completing Petition for Conciliation**

**The Caption:** The caption is the information in the upper left of the first page of the form.

o Fill in your name, street address, city, state, ZIP, telephone number

#### Case No.

 Clearly print your Superior Court Case Number if a divorce petition has been filed. If there is no divorce pending, leave the case number blank.

### Petitioner

Enter your name as the petitioner if you are the one who wants the conciliation session. The
petitioner for the conciliation may be different than the person who is the petitioner in the
divorce case.

### Respondent

- Enter the name of your spouse.
- 1. Read the statement that a controversy exists and you are requesting the aid of the Conciliation Court.
- 2. If you have children fill in the names and ages of the children who are under the age of 18 who are the natural or adopted children of both you and your spouse. If there are no children put N/A for not applicable on the first line.

### 3. Current case pending

- Check the box as to whether there is or is not a Family Law case that involves you and your spouse. This could be an annulment, a legal separation or dissolution of marriage. If there is a case, fill in the name of the county and the court case number.
- o Put a check mark in the box if you are the petitioner or the respondent in that case.

### 4. Previous conciliation

 Put a check mark in the box to indicate if there has or has not been a petition for conciliation that was previously filed by you or your spouse.

### 5. Address and phone number

- Write in your current address and telephone number and the current address and telephone number of your spouse.
- 6. Write in the name of your attorney and/or the name of your spouse's attorney.
- 7. Put a check mark in the box if you need a conciliation counselor who speaks Spanish (Si necesita un consejero que habla español, favor de indicarlo aquí.)

### 8. Date and Sign

- o Sign your name and enter the date that you signed.
- o Put a checkmark in the box to tell the court who signed the form.

# Instructions for Completing Withdrawal of Petition for Conciliation and Filing the Form

**The Caption:** The caption is the information in the upper left of the first page of the form.

o Fill in your name, street address, city, state, ZIP, telephone number

#### Case No.

- Clearly print your Superior Court Case Number if a divorce petition has been filed. If there is no divorce pending, leave the case number blank.
- Clearly print your Superior Court Conciliation Case Number. This number starts with an X and was assigned after your conciliation petition was filed.

### **Petitioner**

 Enter your name as the petitioner since you were the one who filed the conciliation petition.

### Respondent

o Enter the name of your spouse.

### **Date and Sign**

o Sign your name and enter the date that you signed.

### File the Withdrawal Form

o Take the original form and file it with the Clerk of the Superior Court:
