




Information about remote public audio access to criminal and civil court proceedings

Pima County Superior Court is providing live remote audio access to criminal and civil court proceedings. Hearings are live-streamed through an (audio-only) YouTube channel.

To listen to a hearing:

- Access the Court’s website at www.sc.pima.gov.
- Navigate to the Case Management Services [webpage](#).
- Locate the link “Public Access to Court Hearings.” Click on it.



- Find your hearing on the Court Calendar page by entering the case number, or name of the participant.
- Click on the courtroom number to listen to the hearing.

Search by case number or party name then click on the room number to access the live audio for the scheduled hearing. For cases with a room number "NAB", the hearing is "Not Available for Broadcast" and public access is only available at the courthouse. Probate, family law, juvenile, and mental health hearings are not available remotely due to both the complex nature of these procedures as well as confidentiality concerns. If you are interested in observing any of these proceedings, contact the Court's [community relations](#) department or the judicial division presiding over the matter.
