Statement of Work and Compensation Schedule By the Arizona Superior Court in Pima County Related to Evaluation & Restoration Services

This document sets forth the terms and conditions related to payment for a range of services delivered by a forensically certified Superior Court provider; hereinafter referred to as **Provider**.

The Arizona Superior Court in Pima County, hereinafter referred to as Court, has made this statement of work so as to detail the services expected by the Court and the accompanying compensation schedule for all **Providers** who perform that work.

Overview of Work:

Competency Evaluation – \$625.00

Basic Rule 11 evaluation includes review of records available, interview of defendant, MMSE (with score) is *strongly preferred*, and written report in court approved format. Neuropsychological or any other additional testing (when requested by the **Court**) is compensated at a higher rate to the **Provider** through direct approval from or through the Clinical Coordinator's office. Neuropsychological evaluations can be billed up **\$3500.00** based on testing incorporated. Any testing/tasks done by the **Provider** that was not specifically requested by the **Court** will receive no added compensation.

State of Mind at Time of Offense/GEI Evaluation \$750.00

Standard criminal responsibility assessment includes review of records available, possible interview of the defendant and a written report in the court approved format. No testing unless specifically ask for by the **Court**.

Court Appearances- \$500.00 for up to 4 hours/ \$1,000.00 for over 4 hours in court.

Missed Appointments, Refused, or Canceled less than 24 hours notice - \$175.00

<u>Sexually Violent Person Screening with Consent – \$2,000.00</u>
<u>Sexually Violent Person Screening without Consent – \$1,000.00</u>
<u>Sexually Violent Person Commitment Evaluation – \$4,500.00</u>

Includes travel to ASH, record review, respondent interview, any testing that may be needed to satisfy §36-3704, and a written report in a court approved format.

Restoration to Competency Services (RTC)

Outpatient Restoration – (\$2,500.00 per completed Standard Case, or \$1,000.00 for partial Standard Case; \$250 per hour for Specialty Case). Outpatient Restoration is managed by Superior Court. All Restoration cases are submitted for reimbursement upon completion of the case. Completion and closure of Restoration services is directed by the court.

<u>Standard cases</u> include defendants who are able to participate in group settings or otherwise do not need individualized treatment services due to developmental, psychological, or behavioral challenges. Standard cases will typically include defendants demonstrating an ability to participate in group settings without causing ongoing disruption or otherwise jeopardizing the safety and well-being of the Providers and other participants.

<u>Specialty cases</u> MUST BE PREAPPROVED BY THE CLINICAL COORDINATOR and are those in which the defendant requires individualized treatment and one-on-one educational services, and which are provided directly by the Forensic Expert. This includes defendants requiring the need for an interpreter, and/or defendants unable to participate in group settings due to psychological, cognitive or behavioral needs. Specialty cases may also require the need to include family members or other community support members as part of the process in completing Restoration, such as defendants with Guardians.

Restoration Consultation - A one-time, negotiated fee to a **Provider** (MD, PhD or other appropriate professional) who may be engaged to provide consultation on a specific clinical question within a restoration case. A consultation report is submitted to the requesting program with an invoice to be submitted for payment.

Court Appearances- \$500.00 for up to 4 hours/ \$1,000.00 for over 4 hours in court.
