

# Revocation of Parent's Consent to Guardianship & Petition to Terminate Guardianship

### **What is revocation of parent's consent?**

Minor guardianship is a voluntary process where the parents have consented to the appointment of a guardian. Once a parent is ready to resume their parental duties, they **must** revoke that consent in order to end the guardianship.

### **What is the process to end the guardianship?**

When a parent is ready to resume care of the minor, they will complete the included **Petition to Terminate Guardianship** asking the Court to end the guardianship. Once the request has been submitted to the Court a hearing will be set, at which time a judge will decide whether to end the guardianship.

### **Should I see a lawyer for help?**



Court cases can be very complicated, and even if you are representing yourself you should see a lawyer for legal advice about how the law applies to you and what is best in your particular situation. This might save you time, money, and trips to court and help you to avoid serious mistakes. There are lawyers who will help you on a limited basis. They will only charge for giving the help you need, and you can complete the court papers on your own or ask the lawyer for help.

**Personal information** – Fill in your name, street address, city, state, ZIP code, telephone number.

**In the Matter of the Guardianship of** – Enter the name as the minor or minors and their date(s) of birth.

**Case No.**– Fill in the Case Number that was assigned to the guardianship case.

By signing below, you acknowledge that each statement is true.

1. You are the parent of the minor child or children listed in this petition.
2. Fill in the date you consented to the guardianship.
3. You are ready to take the minor back into your care.
4. You take back the consent you gave for the guardianship.

Enter the date you filled out the form and sign your full name on the signature line.

On page two, fill in the case number again. List the full names and current addresses of the people who you will have mailed copies of this revocation of parent’s consent to.

## You must provide copies to:

The guardian (and co-guardian, if applicable).

The minor (if age 14 or older).

Anyone the minor has lived with in the past 60 days.



**Make Copies!!!** You will need one copy for yourself and one copy for each person who must receive notice. The Clerk will keep the original for the Court.

Take the ***original and all copies*** of the Revocation of Parent's Consent to Guardianship & Petition to Terminate Guardianship to the Probate Clerk of the Superior Court located at 110 W. Congress, Tucson, Arizona 85701. The Clerk will date stamp and return all copies to you.

Finally, mail the stamped copies to each person who must receive notice.
