## **How to File an Application for a Name Change for a Minor**

**You may use this packet if you want to ask for a name change for your minor child and**

- You are a resident of Pima County
- You are 18 years or older
- You are asking to change a minor child's name
- You are the child's parent or guardian

**DO NOT USE THIS PACKET IF YOU ARE ASKING THE COURT TO CHANGE THE NAME OF AN ADULT OR IF YOU ARE ASKING FOR NAME CHANGES FOR MULTIPLE MINORS.**

**FOR A NAME CHANGE FOR AN ADULT, USE NAME CHANGE PACKET 1: NAME CHANGE FOR AN ADULT.**

**FOR A NAME CHANGE FOR A FAMILY, SIBLING GROUP, OR MULTIPLE ADULTS USE NAME CHANGE PACKET 3 (JOINT OR FAMILY NAME CHANGE).**

# APPLICATION FOR NAME CHANGE FOR A MINOR

## STEP 1: FILL OUT THIS PACKET.

Fill out the forms included in this packet. This packet can be found at the Pima County Superior Court Law Library. The law library is located on the second floor of the Pima County Superior Court. You can also download the packet contents online. You can go to <https://www.sc.pima.gov/law-library/forms/> for the required forms.

Your completed packet must contain the following forms:

- A. Civil coversheet.
  - a. Write your name as the Plaintiff and write in your address.
  - b. On the second page check the box for change of name.
- B. Application for Change of Name for a minor.
- C. Civil Default Sheet Name Change
- D. Order Changing Name for a Minor. Fill out only the top of this form.
- E. Notice of Hearing Regarding Application for Change of Name
  - a. Fill out the top portion only: the Court will complete Section 2.

## STEP 2: FILE YOUR PAPERS:

***In Person:*** Bring your original packet and one copy of the packet to Court to file in person. Bring your identification with you. Go to the Clerk of the Court filing counter on the ground floor of the Pima County Superior Court. The Court is open from 8 a.m.-5 p.m., Monday-Friday. You should go to the Court at least two hours before it closes.

***You can file your paperwork in person any day of the week, but walk-in same-day name change hearings are only conducted on Wednesday and Thursday mornings. If you want to be seen the same day you file your packet, please arrive at the Courthouse on a Wednesday or Thursday morning 30 minutes prior to the scheduled hearing times. Wednesday hearings are held at 10:00 a.m., and Thursday hearings are held at 9:00 a.m. and 10:00 a.m.***

***File by Mail:*** To file your packet by mail, send an original packet and one copy and one self-addressed stamped envelope big enough to accommodate copies being mailed back to you. Include a photocopy of your Driver's License in your mailing. Any fees due may be paid by check payable to Clerk of the Court. Mail your materials to 110 W. Congress, Clerk of the Court Civil Division, Rm 131 A, Tucson, Az. 85701.

***Filing fees: You will be required to pay a filing fee before you can file your packet. To find out how much you have to pay to file your packet, please visit the Clerk of the Court's website at [www.cosc.pima.gov](http://www.cosc.pima.gov) or call the Clerk of the Court Civil Desk at 520-724-3210.***

If you cannot afford the filing fee, you may request a waiver or deferral (payment plan) when you file your papers with the Clerk of the Court. If you cannot afford to pay the filing fee, request an Application for Waiver and Deferral from the Law Library and Resource Center or download it and print it from the Pima County Superior Court website at <https://www.sc.pima.gov/law-library/forms/>

***You cannot file your packet without either having paid the filing fee or having received a waiver or deferral. It can take 5 - 7 days to process your request for a waiver or deferral.***

### **STEP 3: YOUR NOTICE OF HEARING WILL ARRIVE IN THE MAIL**

You will receive your notice of hearing in the mail approximately 1 week to 10 days after filing.

If you don't receive your notice of hearing in 10 days after filing, please call the Clerk of the Court Civil Desk at 520-724-3210 for assistance.

***The notice of hearing will include the date and time for your hearing. The Notice will provide a call-in number if you choose to attend your hearing by telephone.***

***\*\*\*\* If you are going to Court for a walk-in name change, you will be escorted to a Courtroom for a hearing on the same day you file your papers. You can only walk-in for a name change on Wednesday and Thursday mornings from 8:00 a.m. to 9:30 a.m.***

### **STEP 4: NOTIFY ANY INTERESTED PARTY OR GIVE PROOF OF OTHER PARENT'S CONSENT**

A judge may decide that the law requires you to notify an interested party. The minor's other parent is often an interested party that must be notified. You can comply with the notice requirement before you file to make the process go faster.

***Consent:*** If the other biological parent knows about your application and agrees to it, you may file a notice of consent with your packet. The form to file with your packet showing the other parent consents to the name change is included in this packet. See "*Consent of Parent to Name Change of a Minor Child and Waiver of Notice.*"

***Providing notice if there is no consent:*** In most cases you must notify the other biological parent about your application to change a minor's name. Notice can be provided by giving the other parent a copy of the notice of hearing and having the other parent sign the Acceptance of Service form in this packet. You may also invite the other parent to attend the hearing.

There are many ways to provide notice depending on the circumstances of your situation. ***If you do not have the other parent's consent or do not have a completed Acceptance of Service form, you cannot attend a walk-in name change. You must attend a hearing to address the issue of notice. Please note that the judge may not be able to grant your request at the first hearing if notice is an issue.***

## **STEP 5: ATTEND THE HEARING**

You may call into the hearing according to the instructions provided on your notice of hearing.

You may also attend the hearing in person. The Courthouse is located at 110 W. Congress, Tucson, Az. 85701

## **STEP 6: AFTER THE HEARING**

If you are in court and attend a walk-in name change, and the judge grants your request, court staff will process your paperwork and give you a certified copy of the order to take with you before you leave the courthouse.

If you attend a scheduled hearing and the judge grants your request, court staff will process the paperwork and mail you a certified copy of your order showing the judge ordered the name change. ***You should receive your order in the mail within 10 days of the hearing. If you do not receive it, please call the Clerk of the Court Civil Desk at 520-724-3210.***

You will only be given 1 certified copy of the Court's order. You can get more certified copies if you pay an additional fee of \$30.50 per copy.
