Victims' Rights

The philosophy of the Adult Probation Department in Pima County is to respect all victims of crime and to ensure their rights as directed or ordered by law. Our department's mission statement includes respect for victims' rights including rights to privacy and confidentiality as well as full participation in the criminal justice process. Our goal is to seek input and facilitate involvement of victims in the restoration process. Victim participation provides a rehabilitative component to the offenders and allows for community restoration. Victims' rights include:

- Right to dignity
- Right to protection
- Right to a speedy trial
- Right to be informed
- Right to attend hearings
- Right to be heard
- Right to restitution
- Right to enforcement



The Adult Probation Department:

- Obtains victims' input during the investigation process including the impact of the offense, restitution amounts and sentencing recommendations.
- Informs victims of their right to be heard at court proceedings.
- Informs victims of notification options.
- Maintains a high focus on the collection of restitution.
- Notifies victims of probationer's release or change in supervision levels on intensive probation cases.
- Researches and responds to victim concerns.
- Brings those offenders who are willfully delinquent in restitution payments to Restitution Court.



"Victims' rights constitute a cornerstone of our Mission Statement. We work hard to make sure that those rights translate to services, beginning with a

complete victim impact statement in the presentence report and continuing through the defendant's final restitution payment (if ordered) to the victim. The sharing of pertinent information by the probation officer with the victim is a key component to the respect we have for victims' rights."
