If you have concerns about jury service because of COVID-19, please complete this questionnaire prior to reporting. The answers you provide are the same as you would provide to a judge in open court. In other words, the answers are to be true and correct and are considered to be given under oath and under the penalty of perjury.

Public health and safety of jurors are a top priority at Pima County Superior Court. The Court has worked with the Pima County Health Department to ensure that appropriate health and safety measures are implemented for juror safety. The Pima County Health Department has reviewed and approved the Pima County Superior Court procedures for conducting jury trials, and those procedures have been deemed to be consistent with applicable federal and state guidance. When those mitigation measures are not followed, the risk of transmission increases. The Pima County Health Department review is designed to identify layered mitigation that should help minimize COVID-19 transmission risk. It is not a representation or assurance that an individual will not contract COVID-19.

5. Typically, a person is not excused from jury service because of their employment. An employer is required to allow an employee to attend jury duty but is not required to pay them (although many do). Jurors are paid \$12 per day for the days they serve on a jury, plus roundtrip mileage to and from the courthouse at 44.5 cents per mile. If a trial lasts more than five days, jurors can apply for and potentially receive the entire amount of their average daily pay, up to \$300 per day.
